Additionally, United Way manages at least 12 AmeriCorps members serving at local agencies, each of whom are tasked with improving the health outcomes for residents through health coaching. Finally, distribution of swim passes through the Mengel Fund increases physical activity for kids in the summer.

Financial Stability - Program funding and volunteer efforts supports the collaborative work of community partners that are working to increase access to affordable housing, help citizens become fully employed and provide emergency services to those in crisis. Additionally, United Way manages at least 1 AmeriCorp member who is serving at a local agency with a focus on working with people to get and maintain employment and 3 AmeriCorps members helping individuals access housing.

Educational Goal - Program funding and volunteer efforts supports collaborative work throughout Douglas County aimed at increasing the number of students who graduate from high school. Funded programs include efforts that assure preschool students enter kindergarten with the educational and social skills necessary to succeed, such as providing support for child care programs. Program funding also supports efforts to assure on-grade achievement of elementary students, including academically enriched after-school programs and efforts to get more books to kids who are at-risk.
